

Selection of priority areas

The selection of priority sectors was based on the SCP assessment that was developed by Ministry of Climate Change and Environment in (2018), in addition to the recent development in the country. Moreover, the major challenges that are faced in the country were taken into consideration.

The following sectors were set as priority based on the UAE's focus areas, which are aligned with the 10 YFP programs. The SCP framework addresses the most relevant sector for green growth, which account for a high percentage of UAE's gross domestic product (GDP) and the impact on natural resources, water, energy, waste, air and climate.
